▶ ELIGIBILITY

FIRST YEAR DIPLOMA IN PHARMACY (D. PHARM.)

The Candidates should be an Indian national.

The Candidate should have passed the HSC examination with Physics & Chemistry as compulsory subjects along with one of the subjects Mathematics or Biology (Botany & Zoology).

FIRST YEAR BACHELOR OF PHARMACY (B. PHARM.)

The Candidate should have passed the HSC examination or its equivalent examination with Physics & Chemistry as compulsory subjects along with one of the subject Biology / Mathematics / Biotechnology & obtained minimum 50% marks (at least 45% marks in case of Backward Class category and person with disability from Maharashtra State only) in the above subjects taken together. Candidate should have obtained score in MHT-CET 2019 or NEET - 2019

DIRECT SECOND YEAR BACHELOR OF PHARMACY (B. PHARM.)

(Lateral Entry): The Candidate should have passed Diploma in Pharmacy with at least 45% marks (at least 40% marks in case of Backward Class category and person with disability from Maharashtra State only) from AICTE/PCI approved institution.

FIRST YEAR MASTER OF PHARMACY (M. PHARM.)

The Candidate should have passed B. Pharm course from any AICTE/PCI approved institution with minimum 55% marks in B. Pharm (50% marks for SC/ST category and person with disability from Maharashtra State only). Candidate should have score in GPAT examination conducted by AICTE.

Ph. D. PROGRAMME:

The Candidate should have passed post graduate degree (M. Pharm.) examination with at least 50% marks or equivalent grade point average (GPA) for open category and 5% relaxation in the required % of marks will be given to the students of state of Maharashtra belonging to SC/ST/DT/NT/SBC/OBC categories.

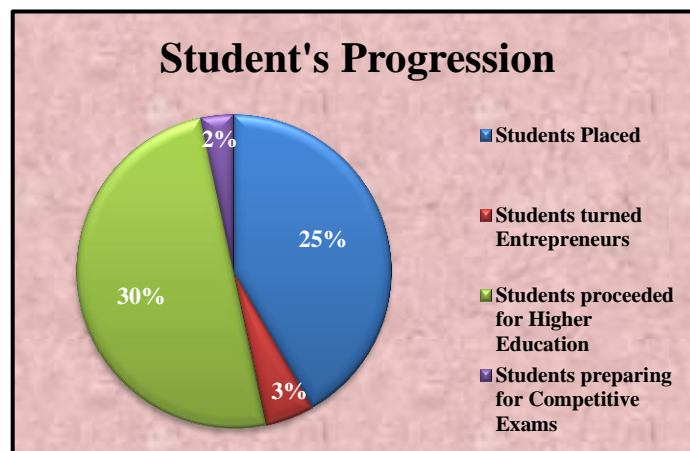
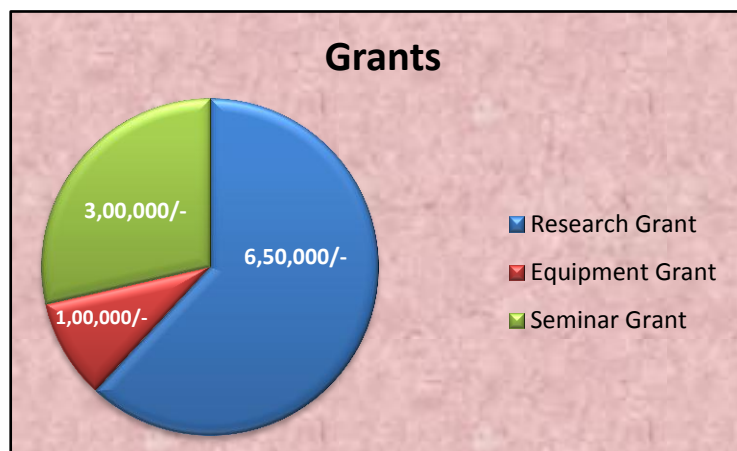

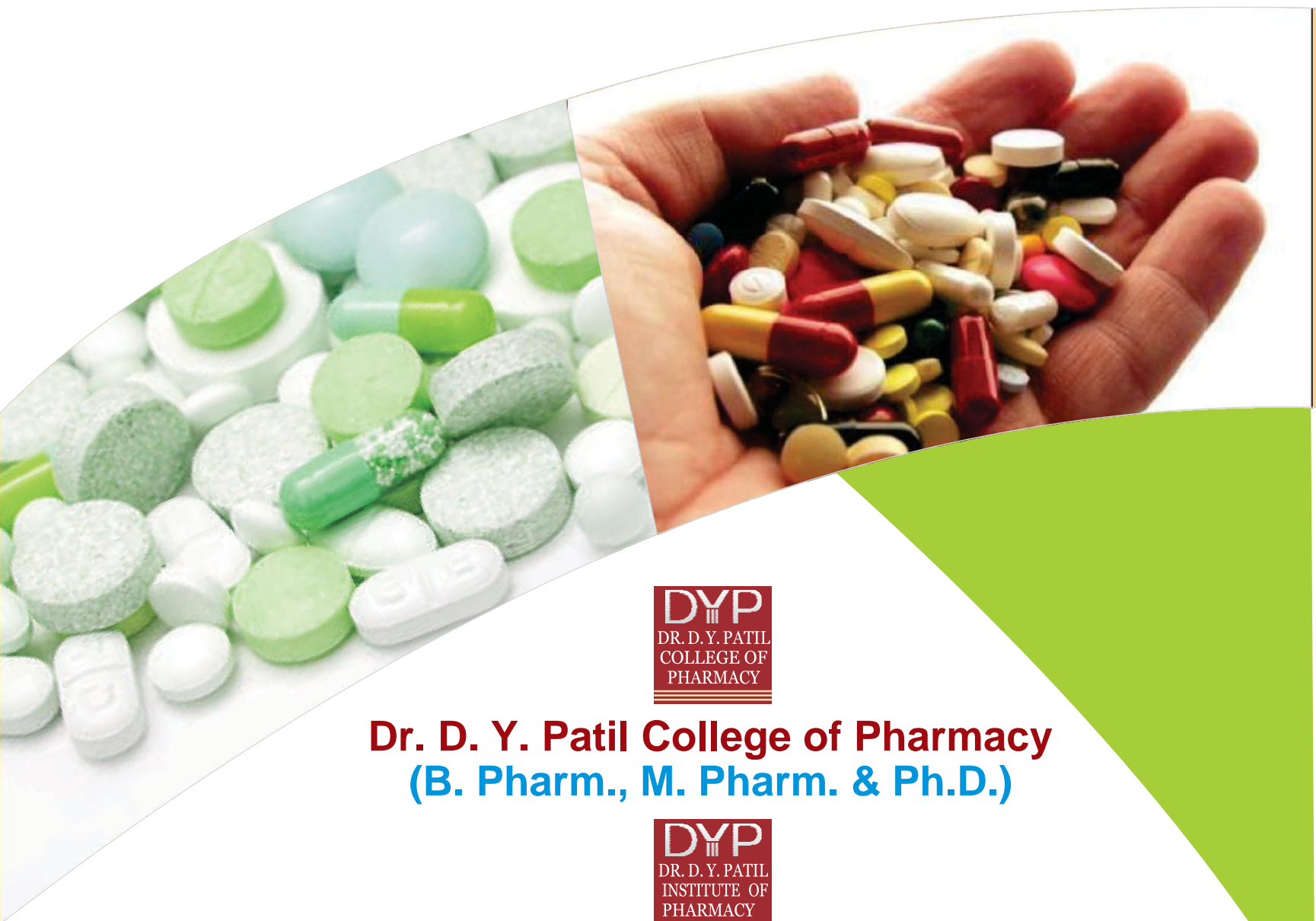
